

Privacy Policy - DigiStu

This privacy policy governs your use of the cloud application DigiStu (“Mobile Application or Website”) for users of academic institutes (i.e. schools, colleges, universities, institutes etc.) subscribed on DigiStu (developed & owned by Zykoon Technologies Pvt Ltd). The Application/Website is a platform to connect students / teachers / institute administration etc. with each other to collaborate, manage entity through various features like forums, notice boards, directory, assignments, creative zone, grievance management etc.

What information does the Application obtain and how is it used?

User Provided Information

The Application obtains the information you provide when you register with the Application. When you register with us and use the Application, you generally provide (a) your name, phone, address, profession, registration number, level, email address; etc (b) information you provide us when you contact us for help; and; (e) information you enter into our system when using the Application, such as information required by the academic institute.

We may also use the information you provided us to display to other users of same entity as well as contact you from time to time to provide you with important information, required notices and marketing promotions.

Automatically Collected Information

In addition, the Application may collect certain information automatically, including, but not limited to, the type of mobile device you use, your device (desktop/mobile) unique device ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browsers you use, and information about the way you use the Application.

Do third parties see and/or have access to information obtained by the Application?

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties who assist us in operating our application, conducting our business, or servicing you, so long as those parties agree to keep this information confidential. However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses.

We may disclose User Provided and Automatically Collected Information:

- as required by law, such as to comply with a subpoena, or similar legal process;
- when we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request;
- if Zykoon Technologies Pvt Ltd is involved in a merger, acquisition, or sale of all or a portion of its assets, you will be notified via email and/or a prominent notice on our Web site of any change in ownership or uses of this information, as well as any choices you may have regarding this information.

What are my opt-out rights?

You can stop all collection of information by the Application easily by stop using the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network.

Content Posted

You shall not submit, upload or post to forums any content which (1) libels, defames, invades privacy of any person, or is obscene, pornographic, abusive, or threatening; (2) infringes any intellectual property or other right of any person or entity, including but not limited to, violating anyone's copyrights or trademarks; (3) falsifies or deletes author attributions, legal notices or other proprietary designations; (4) violates any law; (5) advocates illegal activity; (6) contains viruses, corrupted files, or other materials that may cause damage to another's computer. By posting any content in the application, you automatically grant to Zykoon Technologies a perpetual, royalty-free, irrevocable and unrestricted worldwide right and license to use, reproduce, modify, adapt, publish, translate, create derivative works from and distribute the posted content or incorporate the posted content into any form, medium, or technology now known or later developed for any purpose, including advertising and promotion, and you automatically waive all "moral rights" with respect to the posted content.

Data Retention Policy, Managing Your Information

We will retain User Provided data for as long as you use the Application and for a reasonable time thereafter. We may retain Automatically Collected information for up to 36 months and thereafter may store it in aggregate. If you'd like us to delete User Provided Data that you have provided via the Application, please contact us at privacy@zykoontech.com and we will respond in a reasonable time. Please note that some or all of the User Provided Data may be required in order for the Application to function properly.

Security

We are concerned about safeguarding the confidentiality of your information. We provide physical, electronic, and procedural safeguards to protect information we process and maintain. For example, we limit access to this information to authorized employees and contractors who need to know that information in order to operate, develop or improve our Application. Please be aware that, although we endeavor provide reasonable security for information we process and maintain, no security system can prevent all potential security breaches.
